### Coaches' Codes of Ethics, Conduct Agreements, and Harassment Guidelines

SkateNZ (NZ Federation of Roller Sports Inc - NZ Artistic Roller Sports Committee) requires that all Accredited Coaches read and understand the following documents, located on the <u>NZ Artistic Roller Sports Committee website</u>.
